


Reader Rock Garden Endowment Fund

The **Reader Rock Garden** is an historic rockery. It dates from 1913 when **William Roland Reader**, as Superintendent of Calgary Parks, Cemeteries & Recreation moved his family to the then barren hillside and began creating his magnificent rock garden. By 1942, when he retired, the garden had acquired an international reputation, and a species collection of over 4000. After Mr. Reader's death in 1943 the Garden went through periods of minimal budgets, and the resulting neglect robbed Calgary of one its finest parks. In 2004 the City of Calgary began the process to restore the Garden it its former glory.

As part of this continuing process, the *Friends of the Reader Rock Garden Society* have established an **Endowment Fund** with **Calgary Foundation**.
